DEI Recommendations

At the end of last year, the Regents of the State of Iowa conducted a study on the DEI programs and efforts at Iowa's public universities to determine their utility to the state. The study reveals, among other things, that DEI programs and efforts are generally supported across groups at Iowa's public universities (See Attachment D of the Report). The Regents make a number of recommendations to Iowa's public universities, including the "eliminat[ion] [of] any DEI functions that are not necessary for compliance or accreditation." (See Attachment A of the Report). The University of Iowa College of Law is required by the American Bar Association to "demonstrate by concrete action a commitment to diversity and inclusion" in both admissions and hiring to maintain accreditation (See Attachment B of the Report, Page 7).
